## **WUMBA Board Meeting**

- I. Call to order: Marge Morgan called the meeting to order at 5:02 p.m.
- II. Roll call & Introduction of Members

Sectionals lost \$5400, and GB lost about half of that. Regional made \$3800+. Net loss on tournaments was \$1600, plus \$900 net loss from other areas.

We also have about \$30k in Treasury bills.
